This privacy policy has been compiled to better serve those who are concerned with how their 'Personally identifiable information' (PII) is being used online. PII, as used in US privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context. #### What personal information do we collect from the people that visit our blog, website or app?

#### When do we collect information?

  - To improve our website in order to better serve you.
  - To allow us to better service you in responding to your customer service requests.
  - To quickly process your transactions.
  - To deliver products or equipment..

## How do we protect visitor information?

Our website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our site as safe as possible.

Personal information is stored behind secured networks and is only accessible by a limited number of persons with special access rights to such systems, and are required to keep the information confidential. In addition, all sensitive information you transmitted to our website is encrypted via Secure Socket Layer (SSL) technology.

We implement a variety of security measures when a user places an order enters, submits, or accesses their information to maintain the safety of your personal information.

Credit card transactions are processed through a gateway provider and are not stored or processed on our servers.

#### The Use of Cookies

Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser that enables the site's or service provider's systems to recognize your browser and capture and remember certain information. For instance, we use cookies to help us remember and process the items in your shopping cart. They are also used to help us understand your preferences based on previous or current site activity, which enables us to provide you with improved services. #### We use cookies to:

- Understand and save user's preferences for future visits.

## **Disabling Cookies:**

### **Third Party Disclosure**

We do not sell, trade, or otherwise transfer personally identifiable information to outside parties unless we provide you with advance notice or have your prior electronic or written consent. This does not include website hosting partners and other parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property, or safety.

However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

We also agree to the individual redress principle, which requires that individuals have a right to pursue legally enforceable rights against data collectors and processors who fail to adhere to the law. This principle requires not only that individuals have enforceable rights against data users, but also that individuals have recourse to courts or a government agency to investigate and/or prosecute noncompliance by data processors.

#### **CAN SPAM Act**

The CAN-SPAM Act is a law that sets the rules for commercial email, establishes requirements for commercial messages, gives recipients the right to have emails stopped from being sent to them, and spells out tough penalties for violations.
